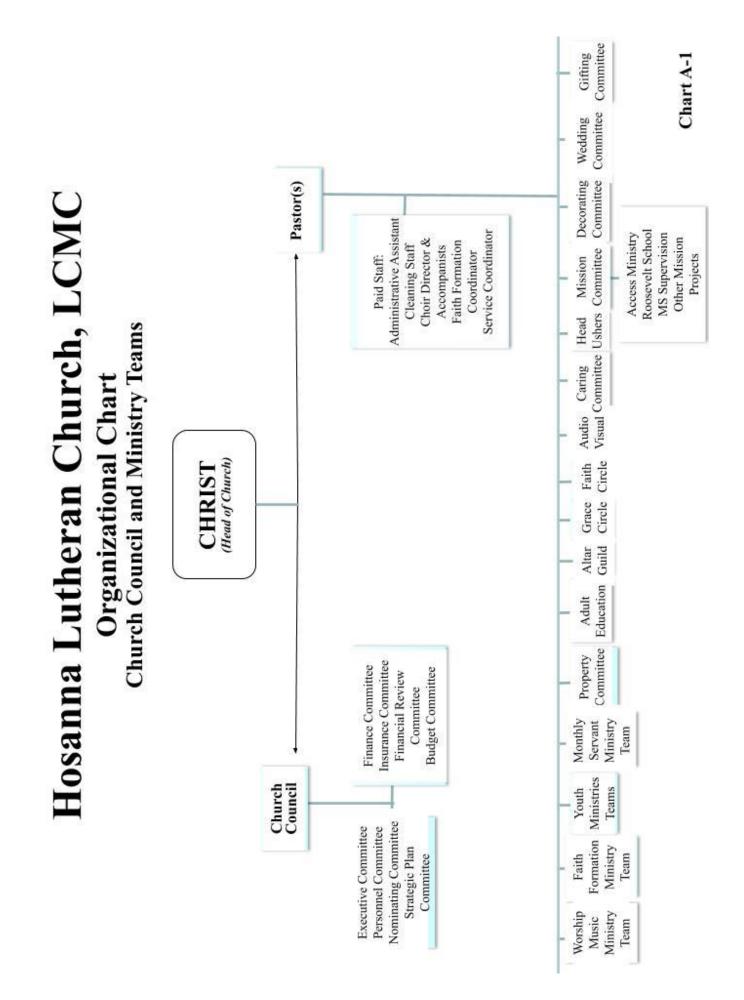

## **Treasurer's Report**

As we close the books on 2023, I am pleased to report the financial position of Hosanna Lutheran Church remains strong.

Stewardship is defined as "Utilizing and managing all resources God provides for the glory of God and the betterment of His creation" In 1 Peter 4 vs 10 *"Each of you should use whatever gift you have received to serve others, as faithful stewards of God's grace in its various forms."* 

In our Budget Process, the Ministry Leaders: the Pastors, Interim Administrative Assistant, Property Committee, Youth and Education Director, Worship Committee, Mission Committee, the Janitorial staff, the Choir, the ladies who provide the music for our church services and the A/V booth provide the numbers for the budget and continue to be budget-minded as they oversee their area of responsibility. We are grateful for their diligence in maintaining the budget approved by the Congregation. All the many volunteers play a part in maintaining the Budget ...... Thank You for all you do!

In 2023, our giving was 14.85 % above the approved 2023 budget and our expenses were 2.76% below the approved 2023 budget. I will be reviewing these numbers in detail at the Annual Meeting.

In 2024, we will continue to streamline and improve our Budget and Financial Process.

In 2026, there will be a review of our debt with Thrivent Financial. The current rate of interest is 3.5%. In 2026, the rate will be reset to whatever Thrivent's rate is at the time, re-amortizing the loan and adjusting the payment accordingly.

## Pastors' Report

"All authority in heaven and on earth has been given to me. Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, teaching them to observe all that I have commanded you. And behold, I am with you always, to the end of the age." Matthew 28:18-20

Hosanna's mission "to spread God's Word, share our gifts and strengthen Christ's Church" is in obedience to our Savior's Great Commission at the end of Matthew's Gospel. We have done our best, by the grace of God, to obey that commission and advance that mission through the opportunities and challenges of 2023, trusting His promise that He is with us always, to His return at the end of the age.

We believe that the mission of the church is to preach the Good News: that the Law confronts us with the reality of our sin and the Gospel promises us forgiveness of sin and salvation from death in Jesus Christ. God keeps His Promises! When He forgives you, it happens! Worship centered around God's Word and the Sacraments is the heart of Hosanna. Worship attendance remained strong throughout the year. From January through May the average attendance was 198. Attendance from June through August averaged 188 (outdoor service 54), and from September through December averaged 238. Live views of the streamed service averaged between 20 and 30 throughout the year. We welcome many visitors every Sunday. We confirmed ten young adults in November and have a wonderful group of six 7th and six 8th graders in class this year.

Hosanna continues to grow at a measured, healthy rate. As of 31 December, there are 580 baptized members, 387 confirmed members, and 250 households on the church rolls. We continue to regularly update the online Church Directory. The proposed 2024 budget increases only .01% (\$51.00) over the 2023 budget. Annual inflation is currently 3.1%. The staff and committees have been very careful to be faithful stewards of your offerings and control spending in 2023 and are very thankful for your generous giving throughout the year.

We are grateful to God for the many blessings He continues to shower on Hosanna, our communities, and our state. Perhaps the greatest blessing, after His Word, is the people who are the faith family of Hosanna. We are thankful for the leadership and volunteers that the Lord continues to raise up here at Hosanna, and for the faith of the Hosanna family. We are grateful and thankful for the wonderful daily ministry of the staff, especially Anna Kettwig in the office, Earl Benson the treasurer, Amber Ottenbacher the chief custodian, Jenn Brist's leadership of our youth and education program, and Melissa Gross' leadership as volunteer coordinator. Thank you as well to Stuart Olson for his tremendous leadership as council president, and to the rest of the council, especially to Stuart Olson, Tammi Krause, and Scott Gilbertson as they conclude their three-year terms, and to Randy Rakness and the members of the Property Committee. We appreciate the tremendous leadership of Angie Eickmeyer, Sarah Becker, Lynn Osthus, and Dorothy Fuller in worship, and Dave Eickmeyer, Dar Carlson and the rest of the A/V volunteers who make a professionally presented worship and livestream possible, the Head Ushers and members of the Altar Guild and Decorating Committee, and Dar, Grant and Alexis Carlson for contributing countless hours of professional IT support.

Hosanna means "Please, Lord, save us." May God continue to bless and guide us as we proclaim His saving Holy Word of Law and Gospel in 2024, the fourteenth of Hosanna's ministry and witness, just as He has saved, blessed, and guided us in 2023.

\*\*We suggest someone speak to Dacotah Bank about the bank charges on our account. We believe there is definitely room to lower or eliminate those monthly fees.

\*\*We feel that Hosanna's records are in order and to continue the process. Checks and balances are in place to keep everything in order. Hosanna's financials are in excellent condition, and the Church Council and Treasurer do an excellent job in keeping our financial structure strong.

## Faith Formation, Youth Group & Vacation Bible School

The presence of children is a gift to the Church; they remind us that our congregation is growing and building the faith of young believers. Children who don't grow up in church certainly don't tend to come to church when they are older. Worshiping with children can be challenging. It will often feel easier to watch online rather than attend in person. Being physically in church allows us to connect and build relationships with each other as a church community. We have 63 children registered for Faith Formation with an average attendance of about 40 children (ages 3 through grade 6) each week. This fall, 20 of our students were in attendance for 75% or more Sundays. That is a remarkable accomplishment!

Angie and Dave Eickmeyer, Darwin Carlson, Grant and Alexis Carlson, Melissa Gross, Ella Olson, Halle Olson, Clair Mohr, and Stuart Olson. Thank you to those who are willing to help with preschool class as needed, and for those who are willing to substitute when teachers are absent.

Approximately 65 kids participated in Vacation Bible School in August. Through the story of Jonah, we learned that God's way is always better than our way! VBS is the biggest undertaking of the year, and we are grateful to everyone who helped in big and small ways.

We are committed to keeping the Word of God in the hands of our young people. Study Bibles were given to our graduating seniors in May. In September the kindergartners received Beginner's Bibles while the third graders received Adventure Bibles. High school students also receive a new Bible for study and journaling when they join the Wednesday night Bible Study.

Wednesday nights are busy at the church. Seventh and eighth graders attend confirmation classes with the pastors, while high school students have their weekly Bible study. We pray that all of our high school students will make Bible Study a priority; it is a good chance to dig deeper in the Bible and grow in your knowledge and faith.

While schedules are challenging, we work to provide opportunities for our youth to pray together and play together. We are blessed with your financial support to make our outings possible without adding stress to families. Whether we are attending Quake (a weekend faith retreat), Christian concerts, playing games, or just hanging out at the fire pit, fellowship is an important part of the Christian lives of our youth. Please encourage the youth in your life to join our youth group activities!

The children and teens of our congregation are blessed by your prayers and encouragement as they grow. We love to see you connecting with the youngest members of our Hosanna family.

## Kids Hope Mentoring 2023

Kids Hope is a faith-based program that provides a framework for matching school children with consistent adult mentors. Hosanna Lutheran and New Life Church share the Kids Hope program at Roosevelt School. One church member is partnered as a mentor with one student for at least one school year. The mentor goes to the school for an hour each week to meet with the student. Kids Hope and local volunteers provide activities for the mentor to use.

Each mentor is matched with a prayer partner from their church. The prayer partner commits to specific prayer for the mentor/mentee relationship, for the child, the child's family, and the school. Mentors and prayer partners must be active members of the partner church for at least six months prior to becoming a mentor.

Nineteen Roosevelt children are currently matched with a mentor, and the effects of these positive relationships have been nothing short of amazing. Five Hosanna members have stepped up to mentor a child: John Larson, Kathy Carlson, Roxy Brenden, Sharon Brekke, and Rose Jones. Their prayer partners are Craig Werling, Alexis Carlson, Tammy Krause, Terry Brekke, and Dana Jones.

Due to declining enrollment in the school district, Roosevelt School will be closing at the end of the school year. We hope to continue Kids Hope in another school next fall. 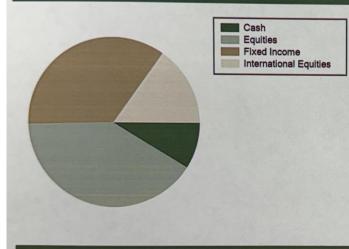

## A TIME OF CHALLENGE AND OPPORTUNITY

Much has been said and written about "LCMC 3.0." The purpose of this report is to frame this within the context and future of the Augustana District. At the last Annual Gathering, participants were asked to provide input around five particular areas of LCMC 3.0. Focus groups met and discussed the following areas: Global Missions, Conflict Management, Intentional Interim Ministry, Clergy Shortage/Next-Gen Leaders/Creative Staffing, Districts and Fellowships.

#### THE NEW ROLE OF DISTRICTS

In order to resist the temptation of addressing the challenges listed above through the hiring of more LCMC staff, districts have been challenged in new ways. According the LCMC website, there are currently eight U.S. districts. All of them are considering ways to address at least three of the challenges listed above: Conflict Management, Intentional Interim Ministry, Clergy Shortage/Next-Gen Leaders/Creative Staffing. All district and fellowship leaders will meet in conjunction with the Board of Trustees and Ministry Board (June 26-28, 2024) to address these challenges.

## AUGUSTANA DISTRICT

As the Augustana District, we remain committed to the ministry we have always had as a priority. At the same time, we are committed to addressing new needs that arise and other areas of ministry (beyond those listed above). For instance, we added a Sr. High Youth Retreat and a First Call Retreat for pastors in 2023. We plan on continuing both. We are also planning to offer call coach training within the district. As one of the larger and more organized districts in LCMC, we continue to provide an important leadership role for other existing districts, as well as new ones.
